3. Section 1.4 Minimum Bidder Qualifications, Page 9

Second paragraph; clarified entities that may meet the requirements.

"Bidders may not use subcontractor's or any other entity's qualifications to meet these requirements."

4. Section 1.4.2 Reference Qualifications, Page 9, and Section 3.2.1.3 Minimum Qualifications – References, Page 33

First Paragraph, Fourth Bullet, updated acceptable launch term.

"Launched with a public launch date that occurred within the last four (4) five (5) years."

5. Section 2.2 General Project Requirements/Deliverable Acceptance, Page 16

First Paragraph, First Bullet, removed hard copy submittal requirement:

"Prior to submitting a final written Deliverable for Acceptance by OPRHP, the Contractor will be required to submit a draft, (one (1) hard copy and one (1) electronic copy) that will be reviewed by OPRHP, NYS Digital Services and the Contractor."

6. Section 2.5.2 Development, Page 20

Added reporting requirements to the bulleted list.

- Provide Weekly project status report: this report will detail accomplishments, milestones, activities falling behind schedule, key planned activities, changes in resources, risks, and mitigation plans.
- Provide Monthly project status report: this report will summarize progress, risks, and issues, and offer suggestions for improvement. It will also integrate bi-weekly sprint reports; and
- <u>Provide Final project report: this report will provide an overview of all project deliverables</u> and lessons learned.

7. Section 2.5.6 Browser Capability, Page 21

Reference to NYS Executive Order 26 is deleted and moved to Section 2.5.8 Accessibility Support.

Third paragraph added to provide direction regarding NYS Executive Order 26.

11. Section 2.14 Key Personnel, 2. Web Designer(s), Page 27

Sixth bullet, WCAG reference updated to the latest version.

"Implementing accessibility requirements for persons with disabilities at the WCAG 2.1 2.2, AA level required for this project."

12. Section 3.2.1.5 Project Management, Page 34-35

First paragraph, last sentence:

"Usage of Agile methodology is preferred required.

Second paragraph:

"The Proposer shall propose a deliverable package structure and project approach in accordance with their proposed Project Management methodology, provided that the first deliverable is an updated and comprehensive-project plan high level Project Management Plan."

Third paragraph, Second sentence:

"This summary must contain an overview of the project management plan Project Management Plan, schedule, and approach while highlighting the unique aspects of the Proposer's response and qualifications."

Fourth paragraph, Numbers 4 through 9

Where previously stated "should" and "shall" is now replaced with "must" to indicate these elements as required of the Proposal.

- 4. The Proposer should <u>must</u> outline a Communication plan that will include frequency of regular progress meetings and written status/progress reports; and
- 5. The Proposer should <u>must</u> describe any innovative project management techniques that they may employ.
- 6. The Proposer shall <u>must</u> describe any limitation of support and maintenance services.
- 7. The Proposer should <u>must</u> describe potential risks that may impact project completion and propose mitigation plan.
- 8. The Proposer should must outline a Quality Assurance plan.
- 9. The Proposer-should <u>must</u> describe Key Performance Indicators (KPIs) and how they will be tracked.
