A. Revisions to IFB

1. Page 12, Section 2.4 Compensation Requirements

Inserted Section

2.4 Compensation Requirements

Contractor will be compensated for each of the following project milestones and the percent remitted will be based on the bidder's not-to-exceed total project budget bid. Compensation will be realized upon contractor submission and acceptance by OPRHP. Milestone 4 may be divided into smaller payments associated with deliverables identified at the sole discretion of OPRHP.

2.4.1 Milestone 1 (10%) Approved Shop Drawings

- 1. <u>Provide Final Shop Drawings to OPRHP for review and approval in</u> accordance with Section 2.1.1 Shop Drawings.
- 2. <u>Final acceptance by OPRHP.</u>

2.4.2 Milestone 2 (30%) AV Equipment

1. <u>In accordance with Section 2.1.2 AV Hardware, provide to OPRHP for</u> review and approval, a comprehensive list of the AV Hardware and accessories proposed.

- 2. <u>Upon OPRHP Approval of the proposed AV Hardware, ship the AV</u> <u>Hardware to OPRHP's Media Developer.</u>
- 3. Final Acceptance of receipt of the AV Hardware by OPRHP.

2.4.3 Milestone 3 (10%) Full-Size Mockup of Kiosk

- 1. <u>Provide a full-scale Mockup of Kiosk in accordance with Section 2.1.3</u> <u>Prototype/Mock-up of Kiosk.</u>
- 2. Final Acceptance by OPRHP.

2.4.4 Milestone 4 (50%) Final Delivery and Acceptance of Kiosks

- 1. <u>Installation and Delivery of Kiosk(s) in accordance with Section 2.1.4</u> <u>Installation and Delivery.</u>
- 2. <u>Final Acceptance by OPRHP.</u>
- 2. Page 26, Section 5.12 Payment Requirements

Fourth Paragraph, Section B, corrected language

B. Invoices should be submitted <u>in accordance with Section 2.4 Compensation</u> <u>Requirements upon completion of delivery and installation of kiosk(s) and acceptance</u> for services rendered by to OPRHP. Invoice Final installation and delivery invoice(s) must include the specific kiosk(s) identification number (if applicable), delivery location and documentation demonstrating date of acceptance by OPRHP.
