First bullet, corrected language

Completion of a prescribed burn will be considered ~~the~~ successful if completed in a manner as described in Exhibit A – Element 5 – Objectives – Resource Objectives – pgs.10-11. Completion of these objectives will be confirmed and verified at the sole discretion of OPRHP’s Biologist. ~~burning of 70% or more of the intended acreage of the prescribed burn unit, as outlined above. If less than 70% of the acreage is burned, the prescribed burn will be considered unsuccessful and result in payment associated with a failed burn. Forested units will observe this as 70% of intended fuels being burned.~~
