12	2.2.1	8	"Include an additional ¼ inch plate on bottom of boat on front 1/3 of landing craft" — Do you require doubled ¼" plate on the entire bottom section of the forward 1/3" of the vessel? Or is an oversize beaching plate acceptable? This would protect approx. 9" outboard on the bottom plate from each side of the keel.	A double 1/4"plate on the entire front 1/3 of the bottom is what is required.
13	2.2.1	9	"Two (2) Stern lifting lugs" - Are bow lifting lugs not required?	No, bow lifting lugs are not required.
14	2.2.1	9	"Self-bailing deck tread plate floor" — Is nonskid paint over aluminum decking acceptable ILO of tread plate decking?	This is not acceptable.
15	2.2.1	9	"Wheelhouse; Two (2) 12" stainless grab handles" —Are brushed welded aluminum grab handles acceptable ILO of Stainless grab handles?	This is not acceptable.
16	2.2.1	9	Work Boat/Landing Craft- Removable stern mast. What are you referring to? Would this same as Tow Post?	This is not the same as Tow Post. Please see Amendment 1 for additional information.
17	2.2.1	9	Do you want us to quote batteries so you can run your engines and accessories? You would also need a battery selector switch would you like this quoted also?	Yes batteries should be included as it is a key part of a boat and utilized to operate. A battery switch should be included also. Please see Amendment 2 for more information.
