The Corporation is overseeing the restoration of Albany's historic Cathedral of the Immaculate Conception. The restoration of the east facade is the second phase of exterior restoration work to address public safety concerns due to loose and falling stone from surface areas of the structure. A successful application would greatly assist the completion of the east facade restoration by allowing replacement of the most deteriorated brownstone wall surfaces while insuring the structural integrity of one of New York's greatest architectural treasures.

The City of Albany, in collaboration with the Arbor Hill Neighborhood Association and the United Way, have identified the North Swan Street Park as a priority for improvements. As an action item in the 2003 Arbor Hill Neighborhood Plan, the North Swan Street Park involves extensive renovation of a one-acre plot that currently includes a basketball court and asphalt area in a state of disrepair. The North Swan Street Park project is continuing the efforts of the neighborhood Plan, the community and strengthening the neighborhood as a whole.

Allegany Town of Hume **Town of Hume Park Improvement Project** \$101,909 The 3.7 acre Park facilities are owned and operated by the Town and include: a playaround, enclosed and accessible picnic shelter area with picnic tables, kitchenette and restroom facilities, grills, and

baseball field with dugouts and backstop. Although the Town and Fillmore Central School District have greatly invested in the park, many areas are in need of improvement, including: new dugouts, batting cages, bleachers, basketball system, benches, trash receptacles, security system, paving of the driveway, and other enhancements.

Extensive exterior and interior stabilization of the 1899 Romanesque Municipal Building Fire Station is essential to restoring the visual prominence of this historically significant building at the entrance of the Village retail district. Rehabilitation of outer brick walls, stone lintels and stone bands, repair of the deteriorating foundation and the return of the clock tower will protect a valuable cultural resource. Interior stabilization will include the repair of the now damp basement area and removal of non historic accretions and environmental hazards thus reclaiming the building for use as an integral part of the Goodwill Theatre Performing Arts Complex and Professional Training Academy housing two performance spaces, and instructor offices.

### **ART Mission LTD**

The ART Mission LTD is a community based arts and independent theater organization, striving to enhance the presence of culture in the Southern Tier. Its goal is to preserve, enhance and revitalize the STRAND Theater at 27 Chenango Street to increase arts and culture awareness in the Southern Tier. The STRAND Theater is an historic building in an historic district that has been left vacant since 1970. This grant will allow the theater to be revitalized it to its 1920's character.

# Preservation of Historic Champlain Canal Structures

The Round Lake Preserve is located one mile from the Luther Forest Technology Park, the center of development pressure in the Town of Malta. The Town purchased the land to permanently preserve a critical area from development for ecological, archeological, open space and recreational protection. When the only public access to Round Lake along the shoulders of Route 9 was closed for safety

The Town will preserve and rehabilitate the stone arch culvert and wastewater weir of the Historic Champlain Canal located over McDonald Creek. The Town along with State and Federal agencies envision the Historic Champlain Canal serving a new educational and recreational resource for citizens and visitors. This project will preserve and increase access to this national treasure of 19th century engineering and craftsmanship for current visitors and future generations to enjoy, and will bring the vision of the Historic Champlain Canal serving as an educational and recreational resource. one step closer to reality.

The Finger Lakes Land Trust, which has protected land in the Finger Lakes region since 1989, will acquire the 65-acre Van Riper tract, which features 1,400 feet of frontage on the western shore of Cayuga Lake, and is bisected by the Cayuga Lake Scenic Byway. Together, the Van Riper tract and the Land Trust's adjacent Whitlock Preserve will provide 1,900 feet of undeveloped, natural shoreline that will be made accessible to the public through the installation of a parking area, interpretive kiosk, and a hiking trail that will provide for access to the lakeshore.

## **Heuvelton Historical Association**

The Association, in the Town of Oswegatchie and the Village of Heuvelton, is dedicated to the gathering, preserving and displaying historical materials, restoring and maintaining historic sites and structures.
