Summary

This Policy implements 9 NYCRR Section 386.1, the Office of Parks, Recreation and Historic Preservation's (OPRHP) regulation authoring the Commissioner to establish no smoking areas at parks, recreational facilities and historic sites under the agency's jurisdiction.

Policy

9 NYCRR § 386.1 prohibits the smoking of tobacco or any other product at no smoking areas designated by the Commissioner. Consistent with the definition of tobacco products used in the Food and Drug Administration's regulations at 21 CFR 1100, 1140 and 1143, this prohibition includes electronic cigarettes (e-cigarettes), vaporizers, vape-pens, vaping, hookah pens, e-pipes and all other electronic nicotine delivery systems or vapes tobacco products.

In addition to the areas designated by this Policy, under Parks, Recreation and Historic Preservation Law Section 3.11 and GOV-POL-007 on Powers, Functions and Duties of the Regional Directors and Assistant Regional Directors, Regional Directors may establish additional no smoking areas at OPRHP facilities for specific events of limited duration and delineate those areas with signs informing the public.

It is expected that patrons will voluntarily comply with the regulation and with this Policy, however, anyone who fails to comply may be issued a ticket for such violation and fined up to \$250 plus the payment of a mandatory surcharge. PRHPL §§ 27.11 and 27.12; Penal Law §§ 10.00(3) and 80.05(4).

The following areas are designated as no smoking and shall be delineated with signs informing the public:
