2024 RULES GOVERNING USE OF ATHLETIC FIELD & TRACK



- **ABSOLUTELY NO spiked shoes or cleats permitted (detachable, molded, metal or rubber).**
- **ONLY turf shoes and sneakers allow.**
- **ABSOLUTELY NO Picnicking, Gum, Food or Beverages are allowed on any portion of the Athletic Field or surrounding Track. Food and Beverages may be consumed ONLY in the cement stands on either side of field.**

- **NO Wheeled equipment or devices (bicycles, scooters, etc.) are allowed on the Athletic Track/Field. ONLY Jogging Baby Strollers are permitted.**
- **NO Kites, Balloons, or other free flying devices (ex: drones) allowed on or over the Track and Field.**
- **NO Sitting on Rails encompassing the field.**
- **NO Climbing or Hanging on Football/Soccer Goal Posts.**
- **NO Smoking is Permitted on Athletic Field/Track. This includes Hookah and Vapes.**
- **Abuse of Field in any form will be grounds for DISMISSAL OR ARREST.**



RULES GOVERNING USE OF ATHLETIC FIELD & TRACK

- **Athletic Field is open for public use from 6:00am to 10:30pm each day unless it is Permitted out for a Special Event.**
- **Denny Farrell Riverbank State Park Reserves the right to close any portion of the Athletic Field, or the track for Repairs or Special Events.**
- **Organizations using the Field MUST dispose of All Garbage Concluding their event or activity.**
- **New York State Office of Parks, Recreation and Historic Preservation will not be responsible for lost or stolen items.**
- **NO one group can monopolize the Field or Track unless they have permitted the space. The Field will be split at the park's staff discretion, so all patrons can enjoy the Track & Field.**



RULES GOVERNING USE OF ATHLETIC FIELD & TRACK

- **Smoking, including hookah and vapes, is prohibited in the Park.**
- **Alcohol is Prohibited in the Park.**
- **Animals are Prohibited in the Park.**
- **Bike-riding is Prohibited in the Park.**
- **Children under the age of (5) are not permitted on the Field without Parent/Guardian accompanying them.**
- **FIRST AID, IF REQUIRED, IS LOCATED WITHIN THE POOL BUILDING.**
